Dear Ms. Miller;

“My father had me talk to a lady attorney. The lady has talked with me a few times in the past couple of days. I have had lawyers before that the court set up for me. They did not listen to me. They did not do what was right. They did not do what was right for me.” I guess, neither did you. More than that, you took what I need and what I want so I can be a happy person, and you pushed for the opposite. I should know. I have lived it both ways. You think you stopped me from being able to say what I know is right by stepping in? Now I see you too. Your actions are unprofessional, unethical and have caused harm.

All this has hurt me. I want to live my life without all of this. I didn't ask my father or anyone else for ANOTHER court person to twist my life and ruin it some more. I was doing fine, with my Mom and writing papers. You had no right to speak about me to anyone. When my father finds out that I am not going back, he will be very very angry. Mr. Shecter will be angry. Maybe even you will be angry. God knows what the group of you will try next to hurt me. Many people know what is really being done to me and my Mom by this. A child of 5 could figure out that the three of you (& J.S.) and whoever are lying together and trying to cover your lies with more and more lies. It just won't fly.

No one told me or my mom you all were going to talk about me not seeing my Mom and without warning, get the court to do what you wanted. You don't know me at all but it's obvious you know Mr. Shecter well. Your actions are prejudiced AGAINST me. My father has threatened me, been abusive to me . He has been neglectful of doing things that really count for a kid. He drinks way too much, yells, screams, starts fights, kicks things and breaks things.
